## A RESOLUTION OF THE MASON TRANSIT AUTHORITY BOARD AMENDING RESOLUTIONS NOS. 2021-31 AND 2024-03 BY APPROVING THE SECOND AMENDMENT TO THE OPERATING GRANT AGREEMENT PTD0344 AND AUTHORIZING THE GENERAL MANAGER TO SIGN THAT SECOND AMENDMENT TO AGREEMENT PTD0344.

**WHEREAS**, by Resolutions Nos. 2021-31 and 2024-03, adopted October 19, 2021 and February 20, 2024, the Mason Transit Authority Board (the "Board") approved Capital Grant Agreements PTD0344 and PTD0344-01, respectively, between the Washington State Department of Transportation ("WSDOT") and MTA and authorized the General Manager to sign that Agreement; and

**WHEREAS,** MTA was awarded additional State Transit Support Formula funds out of the Climate Transit Programs Account in the amount of \$352,645 in addition to the funds previously awarded in the amount of \$952,145 from the Federal Transit Administration 5339 funds. All of which funds to provide funding for sustaining MTA's fixed route and dial-a-ride services for the general public in Mason County with connections to Kitsap, Thurston and Jefferson counties;

**NOW THEREFORE, BE IT RESOLVED BY THE MASON TRANSIT AUTHORITY BOARD** that it approves the Second Amendment to Capital Grant Agreement PTD0344 between WSDOT and MTA ("Agreement") in the total amount of \$1,433,415 with no additional local funds required from MTA; and

**BE IT FURTHER RESOLVED** that the General Manager is authorized to sign the Agreement.
