Mason Transit Authority (MTA) is the municipal agency that provides public transportation for people who live and work in Mason County and surrounding communities. Services include bus routes, paratransit, vanpools, specialized van programs, and active community partnerships. Our mission is to **provide transportation choices that connect people, jobs, and community, increasing the quality of life in Mason County.**

MTA is currently seeking full-time Mechanic. The ideal candidate will have a strong mechanical background with knowledge of all mechanical, hydraulic and electrical systems. This individual has the ability to diagnose and repair diesel, gas and alternative -powered vehicles; maintain consistent safety practices; perform preventive maintenance and routine service of all MTA owned vehicles and equipment in accordance with established Agency standards. Keeps knowledge updated by achieving and maintaining Transit Master ASE certification.

Great benefit package including: medical, dental, vision, life, long term disability, EAP, PERS retirement, optional deferred comp, paid leave days for all.

Requirements/Qualifications:

- Must possess a valid Washington State driver's license;
- Provide drivers abstract dated no more than 1 month prior to application date;
- Successfully pass a background check;
- Must be willing to submit to a post-job-offer employment related physical examination to obtain a valid Medical Examiners Certificate; a USDOT/FTA drug screen; the results of which must meet the agency's hiring criteria;
- Flexibility to work varied days, nights, weekends and holidays; punctuality and reliable attendance are essential;
- Stable employment history;
- Must be able to obtain (within probation period) and maintain a valid Class "B" Commercial Driver's License with air brake restriction lifted.
- Certificate of Completion from a diesel/automotive mechanic vocational college course of study or completion of a certified four (4) year diesel/automotive mechanic apprentice program or current certified ASE Master.
- Must possess a complete set of heavy equipment tools and a roll-a-way tool box necessary to perform the essential functions of the position.

MTA is a drug and alcohol-free workplace. This position is classified as safety-sensitive under MTA's Drug and Alcohol Policy and is included in random drug and alcohol testing program. Note: MTA is subject to requirements of the Federal Drug-Free Workplace Act and CFR Part 40 & 655, which prohibits the use of marijuana at any time while employed with MTA.

SELECTION PROCEDURE:

The most competitive applicants, who in the judgment of the Hiring Manager, who most closely meet the requirements of the position, may be invited to an oral review panel. It is the responsibility of the applicant to supply sufficient information and detail on their resume/application materials to permit the Agency to properly evaluate their qualifications and abilities as they relate to the position.
