## 2023 Financial Plan

The proposed 2023 Budget ensures that Mason Transit Authority continues to meet the needs of the community and operates within its available financial resources. Responsible financial stewardship is exercised by continually identifying organizational efficiencies.

2023 will focus on preparations for future bus technology, staff training and development, and facility planning.

2023 Financial Implications:

- MTA remains conservative with anticipated sales tax revenue. Amounts received in excess of budget will be placed in reserves to ensure future sustainability.
- A return to in-person trainings for staff new to their positions will be supported with an increased training budget.
- Costs of vehicle maintenance parts are increasing as we wait longer for bus replacements.
- Planning for future zero emission vehicle acquisition and facility replacement.
- Maintenance collective bargaining agreement reached with wage adjustments applied.
