

RESOLUTION NO. 2026-27

A RESOLUTION OF THE MASON TRANSIT AUTHORITY BOARD APPOINTING A NEW CLERK OF THE AUTHORITY BOARD AND PUBLIC RECORDS OFFICER.

WHEREAS, pursuant to Section 9.2 of the Bylaws of the Mason Transit Authority ("MTA"), the Authority Board (the "Board") desires to appoint Sabrina D. Arsena, the Executive Assistant, as the MTA Clerk of the Authority Board, to succeed Tracy Becht in that role; and

WHEREAS, Resolution No. 2026-19 approving the Records Management Policy (POL-206), the Authority Board desires to appoint Sabrina D. Arsena, the Executive Assistant, as the MTA Public Records Officer to succeed Tracy Becht in that role; and

WHEREAS, the previously appointed Deputy Clerk of the Authority shall be removed as the employee is no longer employed by MTA;

NOW THEREFORE, BE IT RESOLVED BY THE MASON TRANSIT AUTHORITY BOARD, that the Board adopts the recommendations of the General Manager as follows:

1. Resolution No. 2015-06 appointing Tracy Becht as Clerk of the Authority Board is hereby rescinded; and
2. Sabrina D. Arsena is hereby appointed as the new Clerk of the Authority Board, effective immediately; and
3. Resolution No. 2016-08 appointing Tracy Becht as Public Records Officer is hereby rescinded; and
4. Sabrina D. Arsena is hereby appointed as the new Public Records Officer effective immediately; and
5. Resolution No. 2016-30 appointing the Deputy Clerk of the Authority is hereby rescinded.
